Sales representatives or agents of FCF are not authorized to amend or change the terms of sale or other terms and conditions of the credit granting agreement.
- 2. The Customer (which term includes as entity or individual which has applied and/or have been approved as a customer of FCF and includes any principal, owner or operator of a Customer who applies for credit with FCF) certifies that all statements made in this application, including any attachments, are true and complete.
- a. The Customer hereby consents and authorizes FCF and its agents, contractors and representatives to obtain, collect, verify, copy, use, communicate with disclosed third parties, at anytime, including after termination of FCF's dealing with the Customer, any credit, financial or other personal information requested on the attached credit application or otherwise, including information related to credit rating, financial capacity and payment history for any of the other following purposes:
 - investigation and/or verification of all information;
 - to exchange information with third-parties (including credit reporting agencies, financial institutions, creditors, vendors and other persons);
